### Administration of The Oath

"Members of the Grand Jury, you have volunteered to be Grand Jurors in accordance with The Commonwealth of Australia Constitution Act, Common Law and from The Land and Soil Jurisdiction. The responsibilities placed upon you are solemn and significant. You are entrusted with the duty to fairly and impartially review evidence and determine whether probable cause exists to issue a Formal Indictment to the alleged defendants named on this form, and safeguard the principles of justice in this nation through the free will good faith participation with this Grand Jury Indictment for the restoration of Justice in a peaceful and safe manner.

### Grand Jury Oath

I do solemnly affirm that I will diligently and impartially inquire into all matters that come before this Grand Jury, according to the best of my knowledge and ability.

I will uphold the principles of justice as all are equal before the Law, ensuring that no individual is wrongfully accused and that all evidence is fairly considered.

I am of sound mind and reason, and participate from free will in good faith, to render my decisions based upon lawful due process regarding the evidence presented, and with my best judgment, free from bias, fear, or favour. I will neither indict any person through malice nor fail to indict through undue influence or fear.

I will faithfully discharging my duties as a Grand Juror to the best of my ability, so help me God and under the penalties of perjury."

5. Genocide/ Democide (murder by Government)
6. Crimes Against Humanity.

8. Gaining a Financial Advantage by Deception.
9. Referendum Frauds.
10. Making False Oaths.
11. Slavery & Torture.
12. Other Crimes: [to be Specified by the prosecution]



# Legal Safeguards & Protection for Participants

## 1. Jurisdictional Immunity:

- All participants operate under Common Law and the Law of the Land.
- No consent is given, implied or otherwise, to be governed under maritime, admiralty, or corporate statutory systems.
- Any attempt to subject participants to unlawful jurisdiction shall be deemed fraudulent and void ab initio.

## 2. Sovereign Status & Protection from Retaliation:

- Each participant is Sui Juris (of their own right), acting as a living man or woman, fully competent to manage their own affairs.
- No Grand Jury participant shall be subjected to reprisal, coercion, or persecution for lawfully executing their duty.

## 3. Recognition under Universal & Natural Law:

- This Grand Jury operates within the framework of Natural Rights, the Nuremberg Code, and the Universal Declaration of Human Rights (UDHR).
- The right to redress grievances is protected by international and Common Law principles.

## 4. Public Record & Notarization:

- This oath, once signed, shall be publicly recorded and witnessed by three individuals or notarized by a Justice of the Peace.
- Thumbprint authentication (optional) may be affixed in red ink.

## Legal Basis & Submission Protocol

### 5. Due Process & Fair Trial Rights:

- Each individual listed shall be afforded the right to a fair hearing before a properly constituted Common Law Court and/or The People's Court
- Indictments are subject to review by the Grand Jury, ensuring probable cause.

### 6. Affirmation & Consent to Jurisdiction:

- The undersigned affirms that all claims are made in good faith and within the principles of justice and accountability.
- No assumption of corporate, maritime, or admiralty jurisdiction is acknowledged or consented to.

All are equal before the Law and there is no such thing as corporate immunity.
